

## PAF HAJJ CONTINGENT – 2015

1. PAF Hajj Contingent-2015 will Insha Allah proceed from Islamabad and Karachi to Jeddah (Saudi Arabia) in two components by Airline and C-130 respectively. Airline component shall be of 40 days approx. The pilgrims will stay in Makkah for 20 nights in **Clock Tower Complex**. C-130 component will join them and stay at Makkah in the same hotel for 09 nights. Both components will stay for 09 nights in Madina. Stay in Azizia shall be 03 days prior to Hajj and 02 days afterwards. Tentative Itinerary is attached as Appendix “A” & “B” respectively.

2. This year efforts were aimed to finalize a package which provides the pilgrims the best value for their money; with a focus on better services during the main element of Hajj i.e., **Mashair** days. PAF Contingent shall stay in **Maktab No1 (VIP)** with most exclusive services. Salient features of the package are attached as Appendix “C”.

3. Pilgrims are being offered different rates for double, triple and quad rooms to get most economical rates as per size of the family. Effort will be made to accommodate single personnel in quad sharing rooms. However, this will be subject to total size of the contingent. Rates of the package are as follows:-

**Note:** Airfare will be charged as per actual cost. A tentative amount of **Rs. 135,000/-** has been considered for submission of bank draft.

### Eligibility

4. The following are eligible to apply:-

(a) All serving PAF Officers, JCOs, Airmen, Civilians and their dependants (including personnel on LPR whose dates of SOS fall **after** 24 November, 2015) are eligible to apply. Details of various categories are mentioned at Appendix ‘D’ to AFO 166-13. Service points will be calculated on the basis of Datum date as **30 June, 2015**.

- (b) Serving personnel, who had performed Hajj alone (through PAF / civil before or after joining PAF) and five years have passed, may apply for Hajj with wife / mother, for Airline Component only.
- (c) Retired PAF officers and serving Army / Navy officers (on Secondment with PAF) are eligible to apply for Hajj in Airline component only.
- (d) All the intending serving personnel shall proceed on Ex Pak leave.
- (e) In case of Lady Officers Mehram must be Husband / Father / Son (above 18 Yrs) only.

5. The following are **ineligible** to apply:-

- (a) Those who have performed Hajj in last 05 years.
- (b) Those, who have been posted / deputed / on course to Middle East for more than one year during the last ten years. However, if they have performed Hajj alone during that period they may apply with dependent on Airline component only.
- (c) Those who are under training for any service course.
- (d) Persons, who are suffering from any communicable disease.
- (e) Ladies without "Mehram" or in advanced stage of pregnancy.
- (f) Personnel, who are not confirmed or are on probation service including those, who have been employed on F-497.
- (g) Individuals who are sick / very old / medically unfit (could have difficulty in performance of Hajj Manasik).
- (h) Personnel under treatment for fractured limbs or suffering from any acute disease like ischemia and bronchial asthma etc.
- (j) Those who are under trial or against whom an inquiry has been ordered.

**Required Documents**

6. Hajj applications filled in as per **as per attached forms** alongwith following documents are required to reach Directorate of Welfare latest by **20 June, 2015** positively:-

- (a) 03 photocopies of Computerized National Identity Card. CNIC must be valid up to **31 March, 2016**.
- (b) 03 photocopies of Computerized National Identity Card of heir (NoK/ Any blood relative).
- (c) Blood group (self and dependent).
- (d) 08 photographs (4x3cm) with light blue back ground (**for ladies with neck, ears and hair covered**).

(e) International passports (Machine Readable Green Passports) must be valid up to **31 March, 2016**. In case passports are under issue, attach photocopy of NADRA token.

(f) Family relationship certificate for dependents, if not shown in the passport.

(g) A Bank Draft for C-130 / Airline Component in favour of Directorate of Welfare Air Headquarters, Islamabad.

7. **Para for Retired PAF Officers.** All retired PAF Officers and their dependants are eligible to apply for Airline Component only. Dependents include children / Spouse / Mother for retired PAF Officers.

8. Bases / Units / Factories Adjutants are to disseminate this information to all through repeated entries in the BROs / UROs / FROs at least twice a week. In addition, announcements after Maghrib Prayers may also be made intermittently in mosques. In case of any query contact Dte of Welfare at phone 5131 / 5147 and Defcom 402665 / 401333

9. All ADs AFOHS (Detts) / PAFROA Offices are to display notices bearing abovementioned details at main entry gates, community centers, central mosques of respective housing schemes. Additionally, appropriate announcements in the central mosques of AFOHS (Detts) may also be made for wide publicity. Information is also available on PAF Intranet and PAF Website [www.paf.gov.pk](http://www.paf.gov.pk). Applications received after due date will not be entertained.

10. All efforts have been utilized to make the packages comfortable, economical and viable for the intending Hujjaj of PAF. **Nevertheless, Hajj is a tiring and gruesome activity which demands determination and patience to reach its culmination. It is requested that pilgrims are expected to fully cooperate with the on-site administration (Contingent Commander, Liaison staff) to make the activity a memorable and spiritually gratifying experience.**

## SALIENT FEATURES OF THE PAF HAJJ CONTRACT-2015

### Accommodation

#### 1. Mina

- (a) **Maktab No 1 (VIP)** has been selected, which is closest to Jamaraat. The Maktab provides top quality and luxurious facilities.
- (b) The exclusive tents at Mina will have Gypsum Board walls which will provide better insulation and ensure better cooling. The tents will be spacious as they will accommodate only **14** persons per tent. Three times meals would be served in Buffet style. 24 hrs availability of Cold drinks would be ensured.
- (c) A main element is **private washrooms** for the PAF contingent at Mina. This obviates the need for standing in long queues adding to comfort of the Hujjaj.
- (d) Additionally an exclusive **Air Conditioned tent** would be provided at Arafat.

#### **Makkah (Zam Zam Hotel)**

- (e) The accommodation at Makkah will be in **Zam Zam Hotel** which is a **5 Star** property, located in the Clock Tower steps away from the Haram courtyard. The accommodation shall be double / triple / quad sharing i.e. 02 / 03 / 04 persons per room (for members of same family) with attached bath.

#### **Madina (Hotel Grand Dar ul Eiman)**

- (f) The accommodation at Madina will be in **Hotel Grand Dar ul Eiman**. The hotel is a 4 star property close to Roza-e-Rasool (SAW). The accommodation shall be double / triple / quad sharing i.e. 02 / 03 / 04 persons per room (for members of same family) with attached bath.

#### **Aziziah (Building Accommodation)**

- (g) Both components will move to Aziziah on 04/05 Zil Hajj. Here the contingent will stay in a building accommodation on gender based sharing (max 4-6 persons per room). Pilgrims applying for Double, Triple or Quad (Family rooms) will not be given family rooms in Aziziah building. Instead male / female pilgrims will be accommodated separately.
- (h) Room plan shall be made to provide the most optimum solution for all pilgrims. Pilgrims are requested not to ask for any changes in room plan. Female pilgrims will not be adjusted with non Mehram male pilgrims under any case as per Saudi laws and PAF's SOP.
- (j) The building will remain booked for the contingent till their return to Pakistan on 14/15 /16 Zil Hajj.

**Food**

2. The package includes Breakfast and Dinner at both Makkah and Madina in the hotel restaurants. At Azizia and Mina, three times meals would be served in Buffet style with 24 hours availability of cold drinks. Additionally welcome drinks / refreshments would be served on arrival at Airport and meals would be served on arrival at Makkah & Madina as well as during inter-city travel.

**Transport**

3. The package includes travel by luxury air-conditioned buses. Pilgrims would be accommodated on seat by seat basis on each journey. A special feature is availability of these private buses during travel from Mina to Arafat / Muzdalifa and back. However, as per Saudi Govt regulations buses from Jeddah airport to Makkah and vice versa shall be provided by Moallim.

4. The package also includes Visa endorsement, Qurbani, Limited Laundry facilities, Zam Zam (05 liters each), Vaccination arrangements and Hajj Kit.

5. The contractor will arrange collective visits to Holy places (Ziaraats) at Makkah and Madina (with proper guide) on good quality, air conditioned, seat to seat buses.

**Administrative requirements**

6. **Hajj Dues:-** The cost mentioned in this letter is a tentative one. Changes may occur due to fluctuation in Airfare, rate of Saudi Riyal / Govt Policy etc. All expenditures will be charged as per actual.

7. **Cancellation of seats.** As a matter of policy, seats once allotted will not be cancelled. However, in case of operational commitment or extreme compassionate grounds, request may be addressed to DCAS (Admin) for approval. Following conditions will apply:-

**Travel During Mashair Days**

9. All moves during Mashair days will be dependent on Maktab wise schedule issued by Govt of KSA. The contingent will move accordingly. Pilgrims are to strictly abide by move timings as instructed by contingent commander / liaison staff

10. The transport shall be available during Mashair days. However, due to traffic restrictions imposed by Govt, traffic becomes jammed and it is often convenient to travel from Muzdalifa to Mina on foot. Pilgrims should be prepared for such eventualities. Move for Tawaf-e-Ziarat shall be carried out by pilgrims independently
