

**PAF UMRA CONTINGENT – 2016 (FEBRUARY)  
PAF PERSONNEL**

1. Dte of Welfare has planned Umra Contingent-2016 by commercial airline in the **second week of February 2016**. Efforts have been made to negotiate a package which provides the best value in terms of quality services and cared for at minimum cost.

2. Eligibility criteria is given in Para 2 of AFO 166-18 dated 22 August, 2007. The tentative package cost per head excluding airfare and details of services are appended below:-

**Note:** - The above mentioned departure schedule is tentative because of visa process formalities and departure dates may slightly change if required. Moreover, cost of air ticket is not included; the departure of the entire contingent would be from Benazir Bhutto International Airport Islamabad.

4. Intending PAF serving / retired personnel are to apply on prescribed Umra application forms alongwith following documents as per format given in AFO 166-18 dated 22 August 2007.

(a) Machine readable International Green Passport (having at least four blank pages) valid for 08 months (i.e. 15 Aug 2016) alongwith photocopies of first four pages.

(b) International Health Certificate for vaccination (valid certificate with endorsed meningitis & polio vaccination from approved federal / provincial health centre).

(c) 04 passport size photographs (4x6 cm) with light blue background. **In case of ladies, photographs with neck, ear and hair covered.** (Any change in background colour would be intimated promptly).

(d) Ex-Pakistan leave certificate duly approved by the competent authority for all serving personnel.

(e) Original CNIC or form 'B' in case of under 18 year's children along with 03 photocopies each.

(f) Certificate regarding declaration of religion

(g) Undertaking certificate as per AFO 166-18 dated 22 Aug, 2007.

5. The applications duly filled in along with documents mentioned in above and **Bank Draft** in the name of Dte of Welfare, AHQ Ibd is to reach Dte of Welfare latest by **18 January, 2016** positively. **Applications received after due date will not be entertained.**

6. AHQ (Personnel Branch), Islamabad, Airmen Management Office, Peshawar and Directorate of Civilian Personnel, AHQ Peshawar are requested to expeditiously process Ex-Pak leave applications of intended serving Umra pilgrims for early approval.

7. Bases / Units are to inform all personnel about the above contents **through repeated entries in BROs / UROs / FROs or any other means as deemed appropriate. Moreover, notices at all Mosques / Main Guard Rooms / Messes (Officers, Airmen and DSG Messes) are to be displayed. In addition announcements in Mosques after Maghrib prayers may also be made intermittently.**

8. All ADs AFOHS (Detts) / PAFROA Offices are requested to display notices bearing abovementioned details at main entry gates, community centers, central mosques of respective housing schemes. Additionally, appropriate announcements in the central Mosques of AFOHS (Detts) may also be made for wide publicity.
