

PAF HAJJ CONTINGENT – 2016

1. PAF Hajj Contingent-2016 will in-shaa-Allah proceed from Islamabad and Karachi to Jeddah (Saudi Arabia) in three components (02 components on PIA and 01 on C-130). PIA component shall be of 40 days approx. The pilgrims will stay in **Clock Tower Complex** Makkah. C-130 component will join them and stay at Makkah in the same hotel. Short package component would depart as per their convenience in the last week of August, 2016 directly to Madina to join the main component. Tentative itinerary is attached as Appendix “A”, “B” and “C” respectively.

2. This year efforts were aimed to finalize a package which provides the pilgrims best value for their money; with a focus on better services during the main element of Hajj i.e., **Mashair** days. PAF Contingent shall stay in **Maktab No 3** with most exclusive services like air conditioners, fans and independent toilets. Salient features of the package are attached as Appendix “D”.

3. Pilgrims are being offered different rates for double, triple and quad rooms to get most economical rates as per size of the family. Effort will be made to accommodate single individuals in quad sharing rooms. However, this will be subject to size of the contingent. Rates of the package are as follows:-

Eligibility

4. The following personnel are eligible to apply:-

(a) All serving PAF Officers, JCOs, Airmen, Civilians and their dependants (including personnel on LPR whose date of SOS falls after 14 November, 2016) are eligible to apply. Details of various categories are mentioned at Appendix ‘D’

to AFO 166-13. Service points will be calculated on the basis of Datum date as **30 June, 2016**.

(b) Serving personnel, who have performed Hajj alone (through PAF / civil before or after joining PAF) and five years have passed, may apply for Hajj with wife / mother, for PIA Component only.

(c) Retired PAF officers and serving Army / Navy officers (on Secondment to PAF) are eligible to apply for Hajj in **PIA Component only**.

(d) All the intending serving personnel shall proceed on Ex Pak leave.

(e) In case of Lady Officers, Mehram must be Husband / Father / Son (above 18 Yrs) only.

5. The following are **ineligible** to apply:-

(a) Those who have performed Hajj in last 05 years.

(b) Those, who have been posted / deputed / on course to Middle East for more than one year during the last ten years. However, if they have performed Hajj alone during that period they may apply with dependents on PIA component only.

(c) Those who are under training for any service course.

(d) Personnel suffering from any communicable disease.

(e) Ladies without "Mehram" or in advanced stage of pregnancy.

(f) Personnel, who are not confirmed or are on probation service including those, who have been employed on F-497.

(g) Individuals who are sick / very old / medically unfit (could have difficulty in performance of Manasik Hajj).

(h) Personnel under treatment for fractured limbs or suffering from any acute disease like ischemia and bronchial asthma etc.

(j) Those who are under trial or against whom an inquiry has been ordered.

Required Documents

6. Hajj applications filled in, **as per attached forms**, along with following documents are required to reach Directorate of Welfare latest by **25 May, 2016** positively:-

(a) 03 photocopies of Computerized National Identity Card. CNIC valid up to **10 March, 2017**.

(b) 03 photocopies of Computerized National Identity Card of heir (NoK/ Any blood relative).

(c) Blood group (self and dependent).

(d) 08 photographs (4x3cm) with light blue back ground **(for ladies with neck, ears and hair covered)**.

(e) International passports (Machine Readable Green Passports) must be valid up to **10 March, 2017**. In case passports are under issue, attach photocopy of applied passport token.

(f) Family relationship certificate for dependents, if not shown in the passport.

(g) A Bank Draft for C-130 / PIA Component in favour of Directorate of Welfare Air Headquarters, Islamabad.

7. **Para for Retired PAF Officers.** All retired PAF Officers and their dependants are eligible to apply for **PIA Component** only. Dependents include children / Spouse / Father / Mother for retired PAF Officers.

8. Bases / Units / Factories Adjutants are to disseminate this information to all through repeated entries in the BROs / UROs / FROs at least twice a week. In addition, announcements after Maghrib Prayers may also be made intermittently in mosques. In case of any query contact Dte of Welfare at phone 5131 / 5147 & 5133 and Defcom 402665 / 401333.

9. All ADs AFOHS (Detts) / PAFROA Offices are to display notices bearing abovementioned details at main entry gates, community centers, central mosques of respective housing schemes. Additionally, appropriate announcements in the central mosques of AFOHS (Detts) may also be made for wide publicity. Information is also available on PAF Intranet and PAF Website www.paf.gov.pk. Applications received after due date will not be entertained.

10. All efforts have been utilized to make the packages comfortable, economical and viable for the intending Hujjaj of PAF. Nevertheless, Hajj is a tiring and gruesome activity which demands determination and patience to reach its culmination. It is requested that pilgrims are expected to fully cooperate with the on-site administration (Contingent Commander, Liaison Officer & Liaison Staff) to make the activity a memorable and spiritually gratifying experience.

SALIENT FEATURES OF THE PAF HAJJ CONTRACT-2016

Accommodation

1. **Stay at Makkah.** The airline component will reach Makkah on 07 Zil Qa'ad and stay at five Star Hotel (**Fairmont / Swissotel**) for 19/20 nights. The hotels are considered best five star hotels which are located at the doorstep of Haram. The C-130 component will join them on 17/18 Zil Qa'ad in the same hotel and stay for 08/09 nights.
2. **Stay at Madina.** On 25th Zil Qa'ad both components will move to Madina by bus and stay at five Star Cat B Hotel (**Hotel Royal Inn Nozol / Hayat Intl**), close to Haram. Short package contingent will join the main contingent at Madina in the same hotel.
3. **Azizia (Building Accommodation).** The salient features at Azizia are:-
 - (a) All components will move to Azizia on 04/05 Zil Hajj. At Azizia, the contingent will stay in a building accommodation on gender based sharing (max 4-6 persons per room). Pilgrims applying for Double, Triple or Quad (Family rooms) will not be given family rooms in Azizia building. Instead male / female pilgrims will be accommodated separately.
 - (b) Room plan shall be made to provide the most optimum solution for all pilgrims. Pilgrims are requested not to ask for any changes in room plan. Female pilgrims will not be adjusted with non Mehram male pilgrims under any case as per Saudi laws and PAF's SOP.
 - (c) The building will remain booked for the contingent till their return to Pakistan.
4. **Stay at Mina.** The salient features at Mina include:-
 - (a) **Maktab No 3.** It is a VIP Maktab, which is closest to Jamaraat. The Maktab is also air conditioned with fans and exclusive toilets for PAF contingent.
 - (b) **Arafat.** An exclusive Air Conditioned tent and fans would be provided at Arafat for PAF contingent.

Food

5. The package includes Breakfast and Dinner at both Makkah and Madina in the hotel restaurants. At Azizia and Mina, three meals would be served in buffet style with 4 dishes and desserts along with availability of tea, cold drinks and ice cream round the clock.

Transport

6. The contractor will provide Private chartered luxury air-conditioned buses. Pilgrims would be accommodated on seat by seat basis for each journey. A special feature is the availability of these private buses during travel from **Mina to Arafat / Muzdalifa and back**.

Tawaf-e-Ziarah and Tawaf-e-Widah

7. The contractor shall provide the special air-conditioned buses for Tawaf-e-Ziarah and Tawaf-e-Widah.

8. **Miscellaneous Facilities:** The package also includes Visa endorsement, Qurbani, Ziaraat at Makkah and Madina, Laundry facilities, Aab-e-Zam Zam (05 liters each), Vaccination arrangements and Hajj Kit.

Administrative requirements

9. **Hajj Dues:** The cost mentioned in this letter is a tentative one. Changes may occur due to fluctuation in Airfare, rate of Saudi Riyal / Govt Policy etc. All expenditures will be charged as per actual.

10. **Cancellation of seats:** As a matter of policy, seats once allotted will not be cancelled. However, in case of operational commitment or extreme compassionate grounds, request may be addressed to DCAS (Admin) for approval. Following conditions shall apply:-

Travel During Mashair Days

12. All moves during Mashair days will be dependent on Maktab wise schedule issued by Govt of KSA. The contingent will move accordingly. Pilgrims are to strictly abide by move timings as instructed by contingent commander / liaison officer.

13. The transport shall be available during Mashair days. However, due to traffic restrictions imposed by Govt, traffic becomes jammed and it is often convenient to travel from Muzdalifa to Mina on foot. Pilgrims should be prepared for such eventualities. Move for Tawaf-e-Ziarah and Tawaf-e-widah shall be carried out collectively from Azizia building in buses. However, due to traffic restrictions imposed by Govt and traffic jamm, one should be prepared for such eventualities.
